Know All Men by These Presents:

That I, J. A. PITTMAN in the State aforesaid, in consideration of the sum of Twelve Hundred and No/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BEAMON MERCK, JR., his heirs and assigns, forever:

ALL that lot of land situate on the Northwest side of Pittman Circle, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 5 on plat of property of J. A. Pittman and Maggie B. Pittman, made by Piedmont Engineering Service, July 1958, recorded in the RMC Office for Greenville County, S. C. in Plat Book SS, page 33, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Pittman Circle, at joint front corner of Lots No. 4 and 5, and runs thence with the line of Lot No. 4, N. 33-50 W. 136.8 feet to an iron pin; thence S. 56-10 W. 95 feet to an iron pin; thence with the line of Lot No. 6, S. 33-50 E. 136.8 feet to an iron pin on the Northwest side of Pittman Circle; thence along Pittman Circle, N. 56-10 E. 95 feet to the beginning corner.

This is a portion of that property conveyed to Mrs. Lease Pittman by deed of Nellie Grace Brown, dated October 19, 1929, recorded in the RMC Office for Greenville County, S. C. in Deed Book 134, page 342. Subsequently Mrs. Lease Pittman died testate and by her will which is on file in the Office of the Probate Court for Greenville County, S. C., in Apartment 625, File 34, she devised the above property to the grantor, J. A. Pittman.
