Know All Men by These Presents:

That I, J. W. Pitts, in consideration of the sum of Sixty Seven Hundred Fifty and No/100 (\$6750.00) and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ernest Willard Goodnough and Joyce S. Goodnough, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 54 of Orchard Acres, Section 2, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", at Page 6 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Fairhaven Drive at the joint front corner of Lots Nos. 53 and 54 and running thence along the joint line of said Lots N. 77-41 E. 178.4 feet to an iron pin; thence along the line of Lot No. 98, N. 10-04 W. 113.5 feet to an iron pin on the South side of Ridge Spring Street; thence along the South side of said Street, S. 85-36 W. 38 feet to an iron pin; S. 87-40 W. 117.8 feet to an iron pin; thence with the curve of the intersection of said Street and Fairhaven Drive, the chord of which is S. 40-59 W., 26.1 feet to an iron pin on the eastern side of Fairhaven Drive; thence along said Drive S. 8-27 E. 59.4 feet to an iron pin; S. 9-45 E. 64.3 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 648, at Page 197.

As part of the consideration of this conveyance the grantees assume and agree to pay the balance due on the mortgage given by the grantor to First Federal Savings and Loan Association and recorded in the R. M. C. Office for Greenville County in Mortgage Book 821, Page 330, the balance now due and owing being \$12,000.00.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

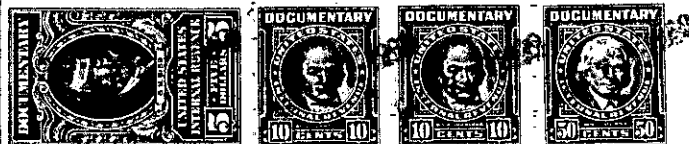
