All that piece, parcel or tract of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, on the East side of the Buncombe Road (U.S. Highway No. 25) and on the West side of Cherrydale Drive, and being more particularly shown and described according to Survey and Plat by Dalton & Neves, November, 1944, recorded in Plat Book M, page 109, R.M.C. Office for Greenville County, as follows:

BEGINNING at an iron pin at the Northwest corner of the tract herein conveyed, which iron pin is on the East side of said Buncombe Road, and running thence N. 73-36 E. 272.4 feet to an iron pin on the West side of Cherrydale Drive; thence with said Drive S. 25-55 E. 318 feet to an iron pin on the West side of said Drive; thence N. 87-51 W. 387.5 feet to an iron pin on the East side of the Buncombe Road; thence with the East side of said Road N. 3-50 W. 195 feet to the beginning.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, her successors, heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and her successors, heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
