All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the West side of White Horse Road, known and designated as Lot No.2 as shown by plat of T. T. Goldsmith property made by W. J. Riddle, Surveyor, June 1944, recorded in the Greenville County R.M.C. Office in Plat Book "O", Page 41 and according to said plat more particularly described as follows:

BEGINNING at a point in the middle of White Horse Road corner of Lot No. 1, shown on said plat, and running thence along line of Lot No. 1, S. 46-30 W. 199 feet to iron pin of rear corner of Lot No. 12; thence along rear line of Lots Nos. 11 and 12, N. 45-20 W. 181.2 feet to iron pin at rear corner Lot No. 3; thence along the line of Lot No. 3, N. 61-55 E. 245.5 feet to point in the middle of White Horse Road; thence along middle of said road, S. 28-05 E. 120 feet to the point of beginning; said lot contains. 76 of an acre, more or less.
