AND SUBJECT TO THE MORTGAGE REFERRED TO BELOW to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ESTON L. RODGERS and JOHN M. FLYNN, their heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Collinson Road, near the City of Greenville, in Greenville County, South Carolina, shown as Lot No. 8 on plat of Sylvan Hills, made June 1948, by Piedmont Engineering Service, recorded in the RMC Office for Greenville County, S. C., in Plat Book S, page 103, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Collinson Road, at the joint front corner of Lots 7 and 8, and running thence with the line of Lot 7, N. 5-36 W., 150 feet to an iron pin; thence S. 84-24 W., 70 feet to an iron pin; thence with the line of Lot 9, S. 5-36 E., 150 feet to an iron pin on the North side of Collinson Road; thence with Collinson Road, N. 84-24 E., 70 feet to the point of beginning.
