FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is BRUCE'S, INC.

THIRD: That the principal place of business is 308 S. Line Street, GREER, S. C.

FOURTH: That the general nature of the business which it is proposed to do is engage in buying and developing real estate, build and lease buildings and all other matters pertaining to such.

FIFTH: That the amount of the capital stock is Eight Thousand (\$8,000.00)----- Dollars payable \$3,000.00 cash and notes receivable of \$5,000.00.
