

All that certain lot of land situate, lying and being in the City of Greenville, State of South Carolina, on the southern side of Mills Avenue, being known and designated as Lat 36, of the Jane G. Hammond property, known as Langley Heights, according to a plat of said property, dated June, 1937, and recorded in the RMC Office for said Greenville County, in Plat Book N, page 133, and having according to said plat the following metes and bounds, to-wit:
