to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto JAMES B. ARROWOOD:

All those pieces, parcels or lots of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 83 and 84 as shown on a plat of Section One of Rockvalé, prepared by J. Mac Richardson, dated October, 1958, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at page 108, and having, in the aggregate, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Sandra Street at the joint front corner of Lots Nos. 82 and 83, and running thence with the line of Lot No. 82 N. 88-02 E. 160 feet to an iron pin; thence with the rear lines of Lots Nos. 101 and 100 N. 1-58 W. 150 feet to an iron pin at the joint rear corner of Lots Nos. 84 and 85; thence with the line of Lot No. 85 S. 88-02 W. 160 feet to an iron pin on the Eastern side of Sandra Street; thence with the Eastern side of Sandra Street S. 1-58 E. 150 feet to the point of beginning.
