That Theodore L. Sawyer, by Margaret D. Sawyer, his Attorney in fact

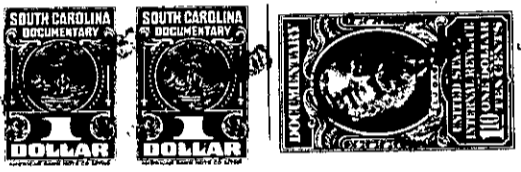
