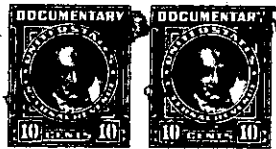

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Philip E. Green and Walter S. Griffin, their heirs and assigns:

ALL that piece, parcel or lot of land situate in Greenville County, State of South Carolina, in the City of Greenville, known and designated as Lot No. 2, Boxwood Manor, and having, according to plat recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book BB at page 85, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Woodland Way Circle, joint corner of Lots Nos. 1 and 2 and running thence along the joint line of Lots Nos. 1 and 2, S. 61-00 W. 296 feet to an iron pin on the East side of Hemlock Drive; thence along the East side of Hemlock Drive, S. 29-08 E. 100 feet to an iron pin joint front corner of Lots Nos. 2 and 3; thence along the joint line of Lots Nos. 2 and 3, N. 61-00 E. 292 feet to an iron pin on Woodland Way Circle, joint corner of Lots. Nos. 2 and 3; thence along the West side of Woodland Way Circle, N. 26-50 W. 100.07 feet to the point of beginning.
