to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto CHARLES DOTSON and JENNIE MAE DOTSON:

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 6 as shown on a plat prepared by J. C. Hill, LS, dated February 12, 1960, entitled "Property of Otis Davis," recorded in the R. M. C. Office for Greenville County in Plat Book TT at page 161, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Maurty Street at the joint front corner of Lots Nos. 6 and 7, and running thence with the line of Lot No. 7 N. 35-55 W. 120 feet to the subdivision property line; thence with the subdivision property line S. 54-05 W. 65 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence with the line of Lot No. 5 S. 35-55 E. 120 feet to an iron pin on the Northwestern side of Maurty Street; thence with the Northwestern side of Maurty Street N. 54-05 E. 65 feet to the point of beginning.

This is a portion of the property conveyed to the grantor herein by deed of Tina G. Davis, et al., dated April 18, 1944 and recorded in the R. M. C. Office for Greenville County in Deed Book 264 at page 81.

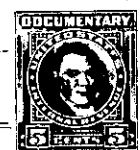
