That I, Mary Walker Robinson

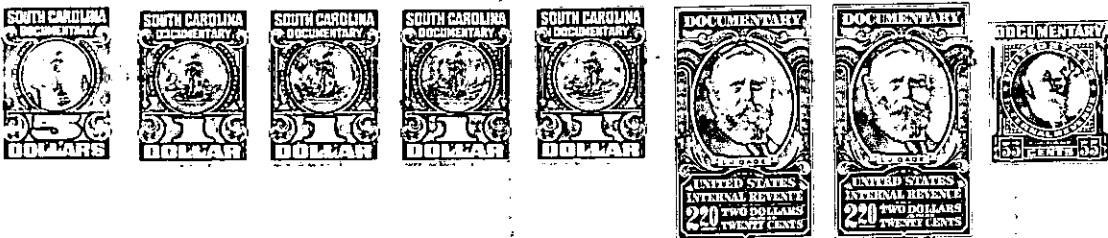
in consideration of the sum of Forty-Three Hundred Twenty-Five (\$4325.00)- in the State aforesaid, - - - - - DOLLARS,
