KNOW ALL MEN BY THESE PRESENTS That I, Mills H. Hughey

in the State aforesaid, in consideration of the sum of \$1.00 love and affection
which I bear my wife, the grantee herein, Dollars
 to me in hand paid at and before the sealing of these presents
 by Louise M. Hughey

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
 these presents do grant, bargain, sell and release unto the said Louise M. Hughey, her
 heirs and assigns:

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, in the city of Greenville, and being known
 and designated as Lot No. 2 on the South side of East Earle Street as
 shown on Plat recorded in Plat Book "G", Page 108, R.M.C. Office for
 Greenville County, and being more particularly described according to
 Survey and Plat by Pickell & Pickell, Engineers, dated March 8, 1946,
 as follows:

BEGINNING at an iron pin on the South side of said Street, front
 corner of Lots Nos. 2 and 3; thence with line of said Lots, S. 17-41 W.
 128.3 feet to a stake on the Northwest side of the Super Highway;
 thence with said Highway, S. 47-30 W. 21 feet to a stake in line of
 Lot No. 4; thence with line of Lot No. 4, N. 71-30 W. 47.5 feet to a
 stake in line of Lot No. 1; thence with line of said Lot, N. 17-41 E.
 150 feet to an iron pin on the South side of East Earle Street; thence
 with said Street, S. 71-30 E. 60 feet to the beginning.

The above described property is the same conveyed to me by Herschel
 M. Talbert by deed dated May 23, 1951, and recorded in the R. M. C.
 Office for Greenville County, S. C., in Deed Book 435, at Page 221.

ALSO

All that certain piece, parcel or lot of land situate, lying and
 being in the State of South Carolina, County of Greenville, on the
 South side of East Earle Street, in the City of Greenville, being shown
 and designated as Lot # 11, Section G, on Plat of Stone land Company,
 recorded in Plat Book A at pages 337-345, and having, according to said
 Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of East Earle Street,
 at the joint corner of Lots #9 and 11, said pin also being 240 feet
 East of the Southeast corner of the intersection of Bennett Street and
 East Earle Street, and running thence with the line of Lot #9, S. 18-30
 W. 206.5 feet to an iron pin; thence S. 71-20 E. 60 feet to a pin, cor-
 ner of Lot #13; thence with the line of Lot #13, N. 18-30 E. 206.5 feet
 to an iron pin on the South side of East Earle Street; thence with East
 Earle Street, N. 71-20 W. 60 feet to the point of beginning.
