BURNS, their heirs and assigns forever:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot 113 on plat of property of M. C. Green as shown on plat recorded in Plat Book O at Page 119, and having the following metes and bounds, to-wit:

BEGINNING at a stake on the northern side of Stadium Drive (formerly Davis Avenue) 200 feet west of the northwest corner of said drive and Rutherford Road; thence with said drive in a westerly direction 125 feet to a point; thence in a northerly direction 240 feet to a point in line of Lot No. 124; thence in an easterly direction 80 feet; thence along the rear line of Lots 110, 111, and 112 in a southerly direction 250 feet, more or less, to the beginning corner.
