C. in Plat Book UU Page 169, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Montclair Avenue, formerly West Fairview Avenue, which iron pin is 277.1 feet in an eastern direction from Townes Street, and running thence N 9-52 E 150 feet to an iron pin in the southern side of an alley; thence along the southern side of said alley; S 80-08 E 66 feet to an iron pin; thence S 9-52 W 150 feet to an iron piniin the northern side of Montclair Avenue; thence along the northern side of Montclair Avenue, N 80- 08 W 66 feet to the point of beginning.
