

All that piece, parcel or lot of land in the county of Greenville, state of South Carolina, being designated as Lot No. 69 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S. in January 1959, and recorded in the RMC Office for Greenville County, South Carolina, in Plat book QQ at pages 36 and 37, and having according to said plat (as amended) the following metes and bounds:

Beginning at an iron pin on the southwestern intersection of Roberta Drive and Red Cherry Lane, and running thence along said intersection N. 34-29 W. 21.2 feet to an iron pin; thence along the western side of Red Cherry Lane S. 10-31 W. 301.8 feet to an iron pin; thence turning and running N. 73-45 W. 115.6 feet to an iron pin; thence N. 10-31 E. 30 S.3 feet to an iron pin on the southern side of Roberta Drive; thence along the southern side of Roberta Drive S. 79-29 E. 100 feet to an iron pin the point of beginning.
