the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Thornie Harrelson and Grace Harrelson, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot No. 61, of a subdivision known as Elizabeth Heights, as shown by a Plat thereof, dated May 1, 1956 by Madison H. Woodward, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 11, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Satterfield Drive, joint front corners of Lots Nos. 61 and 62 and running thence along the line of said lots, N. 73-50 W. 140 feet to iron pin rear line of Lot 3; thence running with rear line of Lots 3 and 4, S. 16-10 W. 87 feet to iron pin on Satterfield Drive; thence running with said Drive, S. 73-50 E. 120 feet to iron pin; thence running, N. 64-10 E. 28.3 feet to iron pin; thence running N. 16-10 E. 67 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.
