All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the corner of McDaniel Avenue and McIver Street, being shown as Lot No. 6, Section 4, Page 92, of the City Block Book, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern corner of McDaniel Avenue and McIver Street, and running thence with McJaniel Avenue, N. 3-00 E. 183 feet; thence S. 85-00 E. 150 feet to corner of W. R. 


