

County Road, joint front corner of Tracts No. 1-C, No. 2 and No. 3, which point is also in the intersection of said County Road and an old road; thence down the center of said old road, S. 23-27 W. 600 feet to an iron pin in the center of said old road; thence continuing down the center of said old road, S. 17-54 W. 500 feet to an iron pin; thence S. 9-19 E. 946 feet (a portion of which distance goes down the center of said old road and crosses another old dirt road) to an old iron pin; thence S. 66-05 E. 840 feet to an old iron pin on the west side of Old Augusta Road; thence S. 65-56 E. 35.3 feet to an iron pin at the eastern edge of the concrete of the Old Augusta Road, joint front corner of Tracts No. 3 and No. 4; thence along the eastern edge of said concrete of said Old Augusta Road and along the line of Tract No. 4, N. 8-05 E. 1687 feet to an iron pin at the eastern edge of said concrete in the intersection of said Old Augusta Road and County Road, joint front corner of Tracts No. 1-C, No. 3 and No. 4, the beginning corner, and containing 34.56 acres, more or less.
