All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and in Butler Township, being known and designated as Lot No. 50 as shown on plat of property of "MORNINGSIDE" as made by Dalton & Neves, Engineers, in December, 1952, said plat being recorded in the RMC Office for Greenville, South Carolina, in Plat Book "FF", Page 85, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Estanolle Street, as shown on said plat, at the corner of Lots Nos. 36 and 50, and running thence N. 70-16 E., along said Estanolle Street 126.5 feet to a stake; thence continuing along said Estanolle Street, N. 79-03 E., 24 feet to the corner of Lot No. 49; thence along the dividing line between Lots Nos. 49 and 50, S. 15-53 E., 200 feet, more or less, to stake in the center line of a certain Creek shown on said plat; thence following the center line of said Creek in a Southwesterly direction, a traverse line of which runs S. 61-09 W., 110.7 feet to a stake at the corner of Lot No. 36; thence along the dividing line between Lots Nos. 50 and 36, N. 26-46 W., 217 feet, more or less, to the point of beginning on Estanolle Street.

Subject to restrictions recorded in the RMC Office for Greenville County in Deed Book 470, Page 369, and subject to the additional restriction that "all tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed."

AS A PART OF THE CONSIDERATION the grantee assumes and agrees to pay the balance, the same being \$12,061.65, on that certain mortgage from the grantor to First Federal Savings & Loan Assn., Greenville, South Carolina, said mortgage being in the original amount of \$14,000.00 and being recorded in the RMC Office for Greenville County.
