Know All Men by These Presents:

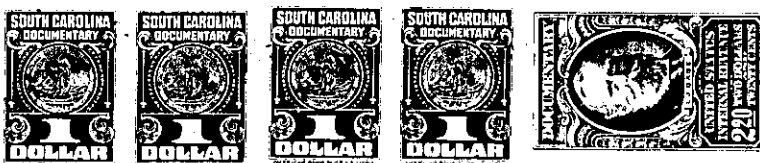
That I, Robert Gordon Smith, in the State aforesaid,

All that certain parcel or lot of land situated on the east side of State Highway No. 14 near the limits of the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being Lot No. 5 of MAPLE HEIGHTS, property of Lee G.
