

in consideration of One Thousand Nine Hundred Thirty Nine and 66/100 (\$1,939.66) --- Dollars, the receipt of which is hereby acknowledged have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James B. Arrowood, his heirs and assigns, forever;

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. Twenty (20) in a Subdivision known as HILLSIDE HEIGHTS, on a plat prepared by R. E. Dalton, Civil Engineer, September, 1920, recorded in the RMC Office of Greenville County, South Carolina, in Plat Book "h", at Page 100, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Converse Street (formerly known as Circle Street), at the joint front corner of Lots Nos. 20 and 21, and running thence along the Southeastern side of said Converse Street N. 48-17 E. 60 feet to an iron pin at the joint front corner of Lots Nos. 19 and 20; thence running with the joint line of said lots S. 48-04 E. 150 feet to an iron pin at the joint rear corner of Lots Nos. 19 and 20; thence running along the rear line of Lot No. 20 S. 47-38 W. 80 feet to an iron pin, being the joint rear corner of Lots Nos. 20 and 21; thence running along the joint line of said Lots N. 40-23 W. 150 feet to the point of beginning.
