ALL that lot of land with the buildings and improvements thereon, situate on the Southwest side of Sedgefield Drive, near the City of Greenville, in Greenville County, S. C., being known and designated as Lot No. 21 on plat of Section III of the subdivision of Timberlake, recorded in the RMC Office for Greenville County, S. C. inPlat Book EE, page 4, and having according to said plat the following metes and bounds, to wit:
