to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said D. H. ROACH, his heirs and assigns forever:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, lying on the southeast side of East North Street in the City of Greenville, being known and designated as Lot 13, College Heights, recorded in Plat Book EE at Page 23, being more particularly shown as property of William R. Williams according to a survey prepared by J. C. Hill in April, 1957, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the southeast side of East North Street at the joint front corner of Lots 13 and 14 and running thence with the line of Lots 13 and 14 and running thence with the line of said lots S. 33-10 E. 200 feet to an iron pin; thence S. 56-50 W. 75 feet to an iron pin, rear corner of Lot 12; thence with the line of said lot N. 33-10 W. 200 feet to an iron pin on the southeast side of East North Street; thence with the southeast side of said street N. 56-50 E. 75 feet to the beginning corner.
