to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JOHN EDWARD GALLOWAY, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 33 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Salem Court at the joint front corner of Lots 32 and 33 and running thence with the Southeastern side of Salem Court S 31-52 W 28.6 feet; thence continuing with the Southeastern side of Salem Court S 34-52 W 72 feet to a point at the joint front corner of Lots 33 and 34; thence S 55-08 E 167.1 feet to a point at the joint rear corner of Lots 33 and 34; thence N 53-10 E 116.6 feet to a point; thence N 31-43 E 11.4 feet to a point at the joint rear corner of Lots 32 and 33; thence N 61-08 W 206.9 feet to the point of beginning.
