to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John R. Finley, his heirs and assigns, forever,

All of that lot of land in the County of Greenville, State of South Carolina, near Greenville, S. C., known as Lot No. 184, Section 2, of the subdivision known as Oak Crest according to plat of C. C. Jones, dated January, 1955, and recorded in the RMC Office for Greenville County in plat Book GG at pages 130 and 131, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Lynhurst Drive, at the joint front corner of Lots Nos. 184 and 185, which iron pin is situate 55 feet southeast of the curved intersection of Texas Avenue and Lynhurst Drive and running thence along the northeastern side of Lynhurst Drive, N. 60-48 W. 55 feet to an iron pin; thence continuing with said Drive at the curve of the intersection with Texas Avenue, the chord of which is N. 15-45 W. 35.4 feet to an iron pin on the southeastern side of Texas Avenue; thence with Texas Avenue N. 29-12 E. 125 feet to an iron pin at the corner of Lot no. 183; thence with said lot 183 S. 63-18 E. 80 feet to an iron pin at the corner of Lots Nos. 183 and 185; thence along the line of lot No. 185, S. 29-45 W. 153 feet to the point of beginning; being the same property conveyed to the grantor by deed dated January 3, 1961, recorded in the RMC Office for Greenville County in Deed Book 665 at page 536.
