All that piece, parcel and lot of land lying and being situate in the City of Greenville, county and State aforesaid, on the eastern side of South Leach Street, comtaining one acre, more or less, and being made up of what was originally two lots known and referred to as Lot No. 6 and Lot No. 8 as recorded in Plat Book A, Page 231, and likewise Plat Book A, Page 229 in the R. M. C. Office, Greenville County, S. C. Lot No. 8 as shown on the mentioned plats was conveyed to Minnie O. Lenhardt by J. W. Gray, Master by deed re-corded in Deed Book UUU, Page 292, R. M. C. Office, Greenville County, S. C. The deed from J. W. Gray, Master heretofore mentioned by its boundaryscalls appears to have been intended as including not only Lot No. 8 on the mentioned plat but likewise Lot No. 6.
