KNOW ALL MEN BY THESE PRESENTS, that We, Joe A. Waters, Lee Jack Waters and C. D. Waters,

in consideration of Three Dollars and division of undivided real estate - - - - - Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

unto James Hugh Waters, his Heirs and Assigns forever,
All of our undivided interest in and to all that certain piece, parcel or tract of land situate, lying and being in the State and County afore-
said, Oneal Township, in the Double Springs community, lying on the west side of a County Road that leads from State Highway No. 415 to State Highway No. S. 42-186, and being shown as tract No. 6 on Plat of Property of Hugh, Joe, Jack and C. D. Waters made by H. S. Brockman, Surveyor, June 30th 1961, and having the following courses and distances, to wit:-

BEGINNING on a stake in the center of the said road, joint corner of tracts Nos. 6 and 7, and runs thence with the common line of tracts Nos. 6 and 7, N. 89-10 W. 30 feet to an iron pin on the bank of the road, then continuing with the same course for a total distance of 1378 feet to an iron pin on the east bank of Enoree River, joint corner of tracts Nos. 6 and 7; thence down and with the meanderings of the river with the following traverse lines (the center of the river being the property line) S. 9-00 W. 63.5 feet to a turn; thence S. 27-05 E. 188 feet to a turn; thence S. 22-27 W. 130 feet to a turn; thence S. 8-48 E. 252 feet to a turn; thence S. 47-02 W. 152.5 feet to an iron pin on the east bank of the river and on the line of tract No. 3 as shown on Plat of Property of R. L. and others made by H. S. Brockman, Surveyor November 23rd 1956; thence with the common line of this tract (No. 6) and of tract No. 3 on the 1956 plat, N. 35-45 E. 58 feet to an iron pin, joint corner of this tract (NO. 6) and of tract No. 3 on the 1956 plat; thence with the common line of tracts 2 and 3 of the 1956 plat and No. 6 of the 1961 plat, N. 80-15 E. 1063.5 feet to a stake in the center of the said road, joint corner of tracts Nos. 5 and 6 on 1961 plat and of tracts 1 and 2 on the 1956 plat; thence with the said road, N. 17-51 E. 130 feet to a turn; thence N. 11-45 E. 320 feet to the beginning corner, containing Sixteen and Seventy Five One-hundredths (16.75) acres, more or less.

THE above described tract is a part of a 128 acre tract willed by Pauline Rebecca Waters to her husband, Joseph Alexander Waters (a life estate only) and then to Lee Waters and his wife Pearl Tate Waters and their Heirs forever. Waters and Pearl Tate Waters are both deceased.
