All that lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being shown as lot 34 on plat of property of Glendale, recorded in plat book QQ at pages 76 and 77, and having the following metes and bounds, to-wit:
