ALL those lots of land situate on the Southeast side of Maple Drive, near the Town of Mauldin, in Greenville County, S. C. being shown as Lots 62, 63, 64, 65, 43 and a strip of land lying South of and adjacent to Lot 43 on Plat of Peachtree Terrace, made by Dalton & Neves, Engineers, January 1956, recorded in the RMC Office for Greenville County, S. BEGINNING at an iron pin on the Southeast side of Maple Drive, at joint front corner of Lots 65 and 66, and runs thence along the line of Lot 66, S. 29-42 E. 167.8 feet to an iron pin; thence N. 60-0 E. 145 feet to an iron pin; thence N. 36-0 E. 289.5 feet to an iron pin; thence N. 49-0 W. 65.9 feet to an iron pin in the Northeast line of Lot 62; thence N. 44-32 E. 175.4 feet to an iron pin on the Southwest side of Peacthree Lane; thence along Peachtree Lane, N. 49-0 W. 72 feet to an iron pin; thence with the curve of Peachtree Lane and Maple Drive (the chord being N. 89-22 W. 57.4 feet) to an iron pin on the Southeast side of Maple Drive; thence with the curve of Maple Drive (the chord being S. 43-58 W. 60 feet) to an iron pin; thence still along Maple Drive, S. 36-18 W. 60 feet to an iron pin; thence still with Maple Drive, S. 32-28 W. 70.1 feet to an iron pin; thence still with Maple Drive,

S. 33-57 W. 37.3 feet to an iron pin; thence still with Maple Drive, S. 39-04 W. 95 feet to an iron pin; thence still along MapleDrive,

S. 46-28 W. 95 feet to an iron pin; thence still with Maple Drive,

S. 53-52 W. 95 feet to the beginning corner.
