This conveyance is made subject to the following restrictions:

(1) No building shall be erected nearer than 40 feet to the front lot line, nor nearer than 10 feet to the side line running along Rocking Chair Road.

(2) No lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any lot other than one detached single family dwelling not to exceed two and one-half stories in height and a private garage for not more than two cars.

(3) No dwelling shall be permitted on any lot with a ground floor area of the main structure, exclusive of open porches, garages or car ports, of less than 1400 square feet for a one story dwelling, nor less than 1000 square feet for a dwelling of more than one story. No dwelling shall be erected on any lot costing less than \$14,000.00.

(4) No lot shall be used for building purposes which shall contain an area of less than 18,000 square feet and which shall be narrower at the building set-back line than 100 feet. This lot shall not be recut in any manner to reduce its size. (continued on reverse side)
