in hand paid at and before the sealing of these presents by Greenville-Spartanburg Airport District (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Greenville-Spartanburg Airport District, its successors and assigns forever, the following described property:

All that piece, parcel or lot of land situate, lying and being in Chich Springs Township, County of Greenville, State of South Carolina, about two miles North of Pelham, South Carolina, on the western side of the Greer-Pelham Road, bounded on the East by said Greer-Pelham Road and by lands now or formerly belonging to the Estate of J. G. Burnett, on the South by lands now or formerly belonging to Nannie J. D. Smith and to Albert L. Smith and Louise W. Smith, on the West by lands now or formerly belonging to P. L. Mayfield, on the North by lands now or formerly belonging to W. Henry Burnett, being known and designated as Tract No. 171 as shown on a plat entitled "Property Ownership Map Prepared for Greenville-Spartanburg Airport Commission", dated June 23, 1960, prepared by Piedmont Engineering Service, and having, according to a plat entitled "Property of J. Mayfield; thence with the line of said Mayfield property N. 2-45 E. 207 feet to an iron pin in the line of property now or formerly belonging to W.
