in the State aforesaid, in consideration of the sum of Five (\$5.00) - - - - - Dollars

to us in hand paid at and before the sealing of these presents by The South Carolina Conference of the Wesleyan Methodist Church of America (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The South Carolina Conference of the Wesleyan Methodist Church of America, its Successors and Assigns forever:

all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, located on the north side of Snow Street, on the west side of South Trade Street and on the east side of Poplar Drive, being shown on a plat made for the S.C. Wesleyan Methodist Campmeeting Association by H.S. Brockman, Registered Surveyor, dated December 13, 1934, and having the following courses and distances, to-wit:

BEGINNING on an iron pin at the intersection of Snow Street and Poplar Drive, and runs thence with the margin of Snow Street, S. 81-19 E. 655.1 feet to a stake at intersection with South Trade Street; thence with the margin of that street, N. 17 W. 483.1 feet to an iron pin; thence S. 73-04 W. 533.6 feet to an iron pin on Poplar Drive; thence with the margin of Poplar Drive, S. 0-54 W. 208 feet to the beginning, containing 4.51 acres, more or less.

ALSO, ALL that other lot adjoining the above described property, lying on the west side of South Trade Street, having the following courses and distances, to-wit:

BEGINNING on an iron pin, corner with the above described property, and runs thence with the west side of South Trade Street, N. 17 W. 78 feet, corner of Copeland lot; thence in a nearly westerly direction, approximately 204 feet to a point; thence S. 14 1/2 E. 78 feet to a point on line of property above described; thence with that line, N. 73-04 E. about 206 feet to the beginning.
