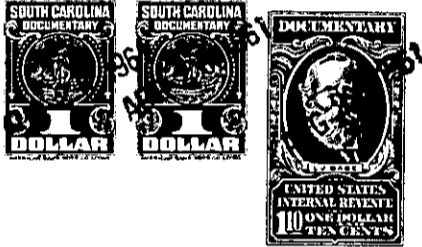
KNOW ALL MEN BY THESE PRESENTS, that Horace P. Baumgardner, as Trustee

All that certain piece, parcel or lot of land situate lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #9, on the southern side of Indian Trail, of a subdivision known as Dogwood Terrace, as shown on a plat prepared by J.
