All that piece, parcel or lot of land on the southern side of East North Street, in the County of Greenville, State of South Carolina, in the City of Greenville, and having the following metes and bounds, according to plat recorded in Plat Book A at Page 179:

BEGINNING at an iron pin on the southern side of East North Street, which pin is 51 feet east of the northeastern corner of Lots 2 and 3 of Block 11, said point also being the northeastern corner of lot formerly owned by J. G. Thornton, and running thence with the line of said lot, S. 15 E. 126.1 feet to pin on a 10 foot alley; thence along said alley, N. 76-45 E. 51 feet to pin; thence N. 15 W. 126.1 feet to pin on the southern side of East North Street; thence along the southern side of East North Street, S. 76-45 W. 51 feet to the point of beginning.

This is the same tract of land which was conveyed to the grantors by deed recorded in Deed Book 562 at Page 209, and deed recorded in Deed Book 563 at Page 413.

The deed of Eva G. Anderson (later Eva G. Metchicas) to Oswald Clayton Polk, recorded in Deed Book 562 at Page 209, is defective in that O. C. Polk witnessed his own deedwhen he was the grantee. Ruth M. Polk joins in this deed, as O. C. Polk conveyed his interest by deed recorded in Book of Deeds 563 at Page 413.

Oswald Clayton Polk is the sole heir at law of Eva G. Anderson (later Eva G. Metchicas), as will appear by affidavit to be recorded herewith.
