in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Mabel T. Glazener, her heirs and assigns forever:

~~All that parcel of land in the County of Greenville, State of South Carolina~~

All of those lots of land designated as Lots 27, 69, 65, 51 and 41 as shown on plat of property of Lula B. Thruston according to plat of C. C. Jones, Civil Engineer, April 1961, labeled as Section 3, Lockwood Heights, Greenville County, South Carolina, said plat to be recorded in Plat Book XX, Page // and said lots being more particularly described according to said plat as follows:

Lot 27--BEGINNING on White Horse Road, joint corner of Lots 27 and 28 and running thence S. 47-39 W. 167.4 feet along line of Lot 28 to rear corner thereof; thence N. 28-18 W. 95 feet to iron pin; thence N. 48-37 E. 145 feet to point on White Horse Road; thence S. 41-46 E. 92.2 feet along White Horse Road to point of beginning.

Lot 69--BEGINNING at the joint corner of Lots 68 and 69 on Saran Drive and running thence S. 18-32 W. 160 feet along line of Lot 68 to the rear corner thereof; thence S. 72-18 E. 59.5 feet to point on Page Drive; thence N. 70-06 E. 114.1/along Page Drive to point thereon; thence N. 25-06 E. 28.3 feet along chord of the circle to point on Saran Drive; thence N. 19-54 W. 25 feet along chord of the circle to point on Saran Drive; thence N. 45-16 W. 90.3 feet along chord of the circle to point on Saran Drive; thence N. 70-41 W. 55.5 feet along Saran Drive to point of beginning.

Lot 65--BEGINNING at the joint corner of Lots 64 and 65 on Saran Drive and running thence S. 25-30 W. 160 feet along line of Lot 64 to rear corner thereof; thence S. 66-32 E. 90 feet to rear corner of Lot 66; thence N. 23-37 E. 160 feet along line of Lot 66 to front corner thereof on Saran Drive; thence N. 65-33 W. 85.5 feet along Saran Drive to the point of beginning.

Lot 51--BEGINNING at the joint corner of Lots 50 and 51 on Saran Drive and running thence N. 22-53 E. 153.7 feet along line of Lot 50 to the rear corner thereof; thence N. 30-30 W. 58 feet to point on Lula Lane;
