Grantee(s), and to the heirs and assigns of said Grantee(s), ALL THAT lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 217 on plat of Augusta Acres recorded in plat book S page 201 of the RMC Office for Greenville County, S. C., said lot having a frontage of 100 feet on the east side of Jasper Drive, a depth of 198.8 feet and a rear width of 86.5 feet.

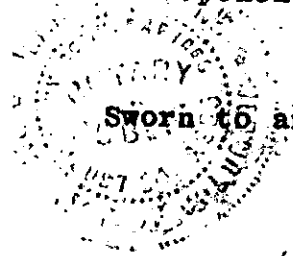
