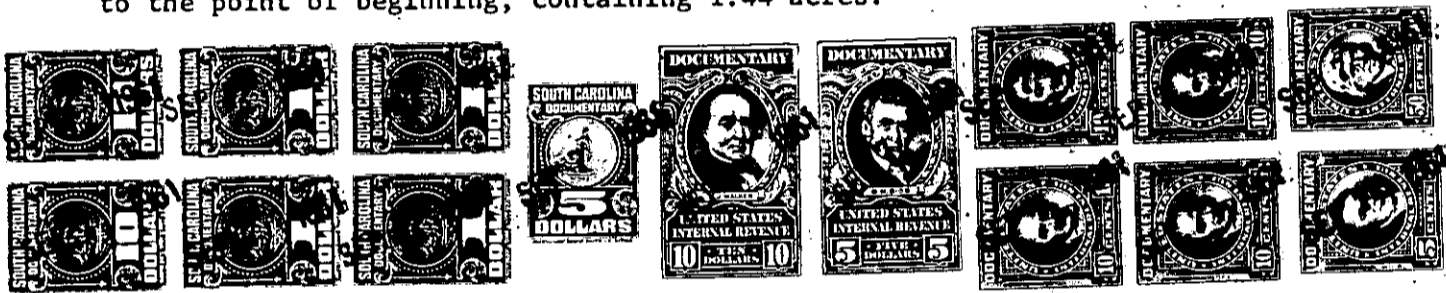
Know All Men by these Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES C. KING, JR., AND M. RAY BRACKEN, their heirs and assigns forever:

All that certain piece, parcel or lot of land, situate on the northwestern side of U. S. Highway 29, in the County of Greenville, State of South Carolina, and having according to plat made by Dalton and Neves, April, 1961, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of U. S. Highway 29, at corner of lot heretofore conveyed by the grantor to the grantees, and running thence with line of said lot N. 48-34 W. 647.2 feet to pin on Pine Knoll Drive; thence with the eastern side of Pine Knoll Drive, N. 18-24 E. 100 feet to pin; thence S. 49-14 E. 689.3 feet to pin on right-of-way of U. S. Highway 29; thence with the northwestern side of said right-of-way S. 43-08 W. 100 feet to the point of beginning, containing 1.44 acres.
