All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 48 of Western Hills, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book QQ, Pages 98-9, and according to said plat having the following metes and bounds, to-wit:
