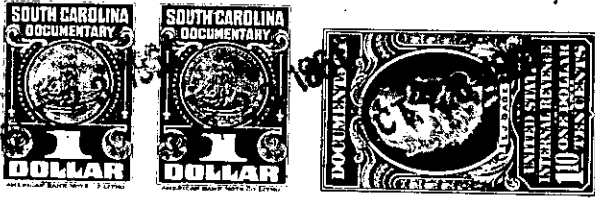

KNOW ALL MEN BY THESE PRESENTS That I, Vera Thompson

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by  
these presents do grant, bargain, sell and release unto the said Mary Bolt O'Shields  
Her Heirs and Assigns:

all that piece, parcel or lot of land in Greenville Township,

County, State of South Carolina, lying and being on the Southwestern side of an  
unnamed street, and being known and designated as Lot No. 24 of Nichol-  
Town No. 4, as shown on plat prepared by J. J. Riddle, Surveyor, dated  
November 3, 1943, and recorded in the R. H. C. Office for Greenville  
County, S. C. in Plat Book "W", Page 139, and having according to said  
plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of an unnamed  
street, joint corner of Lots 23 and 24, which iron pin is also 137.4  
feet from the Northwest corner of the intersection of said unnamed street  
and Arden Street Extension, and running thence along the line of Lots 23  
22, 21 and 20, S. 53-43. 140 feet to an iron pin, joint Corner of Lots  
16 and 24; thence with the line of Lot 16, S. 36-17 E. 40 feet to an  
iron pin, joint rear corner of Lots 15, 16, 24 and 25; thence along the  
joint line of Lots 24 and 25, N. 53-43 E. 140 feet to an iron pin on  
the Southwestern side of the aforementioned unnamed street, joint front  
corner of Lots 24 and 25; thence along the Southwestern side of said  
unnamed street, S. 37-17 E. 40 feet to the beginning corner.
