the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Virgie Lynn Bishop, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Chick Springs Tiwnship, being known and designated as Lots Nos. 29 and 30, of a subdivision known as Holly Vista, as shown by a Plat thereof, dated February 1956, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Arrowhead Lane; joint front corners of Lots Nos. 30 and 31 and running thence along the line of said lots, N. 31-12 E. 150 feet to iron pin rear line of Lots Nos. 26 and 27; thence running with rear line of Lots 27, 28 and 28-A, S. 58-48 E. 123 feet to iron pin; thence running, S. 40-30 W. 152 feet to iron pin; thence running with Arrowhead Lane, N. 58-48 W. 90.4 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS deed is made subject to all easements and rights of way of record.

GRANTEE to pay 1961 taxes.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
