HOLQUINN, Grantee(s), and to the heirs and assigns of said Grantee(s), all that lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 191 on plat of AUGUSTA ACRES subdivision, recorded in Plat Book S, page 201 of the RMC Office of Greenville County, S. C., said lot having a frontage of 100 feet on the northern side of Meadors Avenue, a parallel depth of 221.2 feet and a rear width of 100 feet.
