to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Carey C. Rice, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 132 on the plat of Western Hills, recorded in the R.M.C. for Greenville County in Plat Book QQ, pages 98-9, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Alice Farr Drive at the joint front corner of Lots Nos. 131 and 132, and running thence with the common line of said lots N. 23-30 W., 150 feet to an iron pin; thence S. 61-34 W., 51.2 feet to an iron pin; thence S. 33-54 W., 45.8 feet to an iron pin; thence S. 23-30 E., 120.8 feet to an iron pin on the northerly side of Alice Farr Drive; thence with said Drive N. 66-30 E., 90 feet to the point of beginning.

The above lot is conveyed subject to the recorded restrictions applicable to Western Hills, and to the easements and rights of way, if any, and set back line as shown on said plat.
