KNOW ALL MEN BY THESE PRESENTS, that I, B. W. Runion,

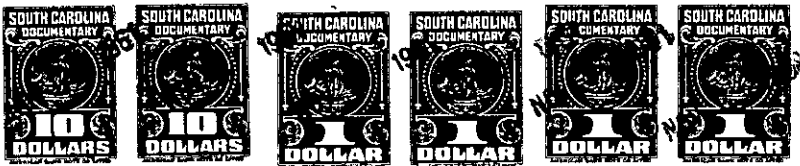
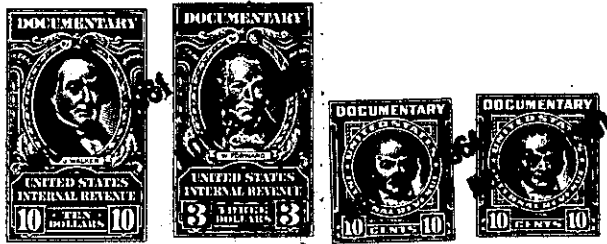
in consideration of Eleven Thousand Seven Hundred Fifty and No/100 (\$11,750.00)----- Dollars,
