in consideration of One Thousand Five Hundred Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. D. Reynolds, his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina situate, lying and being on the Southwestern side of S. C. Highway No. 416 known as the New Cedar Lane Road and being known and designated as Lot No. 9, Block A of Grandview Heights, as shown on Plat thereof by J. Coke Smith & Son, dated May, 1954, and recorded in Plat Book "BB", page 38, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of the New Cedar Lane Road at the joint front corner of Lots Nos. 8 and 9 and running thence along the line of Lot No. 8 S. 45-03 W. 196 feet to a point in the center of Old Cedar Lane Road at the joint corner of Lots Nos. 8 and 9; thence along the center of Old Cedar Lane Road N. 17-16 W. 92 feet to a point at the joint corner of Lots Nos. 9 and 10; thence along the line of Lot No. 10 N. 45-03 E. 155.5 feet to an iron pin on the southwestern side of the New Cedar Lane Road, joint front corner Lots Nos. 9 and 10; thence along the southwestern side of New Cedar Lane Road S. 44-57 E. 83 feet to the beginning corner.
