

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto JAMES F. GALLIVAN:

All that certain piece, parcel or lot of land situate, lying and being on the Eastern side of McDaniel Avenue in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2 as shown on a plat of Alta Vista, prepared by R.E. Dalton, Engineer, dated June, 1925, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book G at page 20, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of McDaniel Avenue at the joint front corner of Lots Nos. 1 and 2, and running thence with the line of Lot No. 1 S. 84-35 E. 164.75 feet to an iron pin in the rear line of Lot No. 13; thence with the rear lines of Lots Nos. 13 and 12 N. 4-15 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3; thence with the line of Lot No. 3 N. 84-35 W. 164.75 feet to an iron pin on the Eastern side of McDaniel Avenue; thence with the Eastern side of McDaniel Avenue S. 4-15 W. 80 feet to the point of beginning.

This is the identical property conveyed to the grantor herein by deed of Fidelity Company, Inc., dated December 30, 1953, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 491 at page 321.
