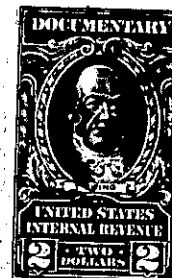
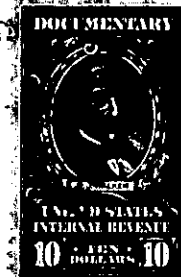

KNOW ALL MEN BY THESE PRESENTS, That HENRY E. BRYANT

in the State aforesaid, in consideration of the sum of Fifteen Thousand Two Hundred
and No/100ths (\$15,200.00) ----- Dollars,
to me ----- in hand paid at and before the sealing of these presents by
THE GREENVILLE-SPARTANBURG AIRPORT DISTRICT

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The Greenville-Spartanburg Airport District, its Successors and assigns.

All that piece, parcel or lot of land situate, lying and being in Butler Township, County of Greenville, State of South Carolina, on the eastern side of the Greer-Pelham Road, bounded on the West by said Greer-Pelham Road and by property now or formerly belonging to James C. Howard, on the South by property now or formerly belonging to Mary E. M. Bridges, on the East by property now or formerly belonging to the James R. Green Estate, on the North by property now or formerly belonging to said Green Estate and to W. Dennis Smith, being known and designated as Tract No. 160 as shown on a plat entitled "Property Ownership Map Prepared for Greenville-Spartanburg Airport Commission", dated June 23, 1960, prepared by Piedmont Engineering Service, and having, according to a plat entitled "Property of Henry E. Bryant", compiled by Piedmont Engineering Service, dated March 15, 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin in or near said Greer-Pelham Road at the joint front corner of the within described premises and property now or formerly belonging to W. Dennis Smith and running thence with the line of said Smith property and property now or formerly belonging to the James R. Green Estate S. 84-02 E. 256 feet to an iron pin; thence continuing with the line of said Green Estate property S. 2-02 E. 354.9 feet to an iron pin in the line of property now or formerly belonging to Mary E. M. Bridges; thence with the line of said Bridges property N. 68-40 W. 288 feet, more or less, to an iron pin in or near said Greer-Pelham Road and in the line of property now or formerly belonging to James C. Howard; thence with said road and the line of said Howard property N. 2-15 W. 295 feet, more or less, to the beginning corner.

This is the identical property conveyed to the grantor herein by deed of J. R. Greene, dated April 7, 1945 and recorded in the Office of the R.M.C. for Greenville County, South Carolina, in Deed Book 283 at Page 218.
