to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Cecil H. Fowler, his Heirs and Assigns forever:

ALL that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in Austin Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 19 of B. F. Reeves Sub-division in accordance with Plat made by H. S. Brockman, dated September 14, 1953, and recorded in the R.M.C. Office for Greenville County in Plat Book "00", Page 190, and being more fully described according to said plat, to-wit:
