All that piece, parcel or lot of land in Paris Mountain Township, County of Greenville, State of South Carolina, located on the Southern side of East Perry Road, and being shown as all of lot number SIX (6) on a plat entitled "Leawood Hills", made for the within grantors by Terry T. Dill, surveyor, dated October 1958, and has the following metes and bounds according to said plat, to wit:

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

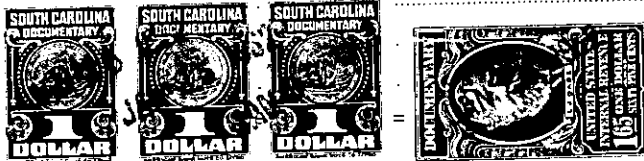
