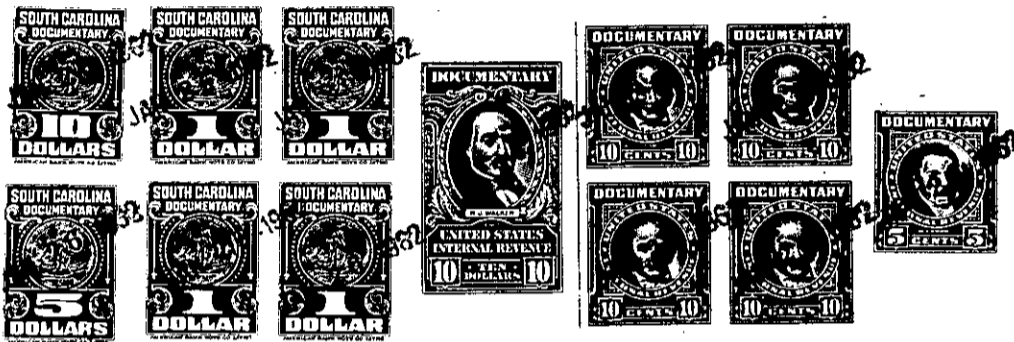
That I, J. Frank Williams

Griffin, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being known as Lot No. 35, Section A, of Oak Hill, plat of which is recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book MM at Page 29, and having, according to a revision by J.C. Hill, August 23, 1961, recorded in the R.M.C. Office for Greenville County in Plat Book ZZ at Page 39, the following metes and bounds, to-wit:

BEGINNING at an Iron pin on the Northwesterly side of Oak Hill Drive, at the joint front corner of Lots Nos. 32 and 35 of said revision, and running thence with the common line of said lots, N. 40-33 W. 94.7 feet to an iron pin; thence N. 35-43 E. 92 feet to an iron pin; thence S. 36-03 E. 116.5 feet to an iron pin on the northwesterly side of Oak Hill Drive; thence S. 49-08 W. 80 feet to the point of beginning.
